

June 3, 2021

The Board of Directors of the Pathfinder Irrigation District met in their office in Mitchell, Nebraska on Thursday, June 3, 2021.

Those presents were: Harry Howell, Jeff Jenkins, Monty Reisig, Alan Fenning, and Mick Lookabill, Directors, Randy Hoff, President, Dennis Strauch, Manager, Rick Miller, Assistant Manager, and Margaret Harriger, Sec.-Treas.

The meeting was called to order at 9:00 a.m. with reference being made to the "Open Meetings Act" as posted in the Boardroom.

The minutes of the last meeting was dispensed with as the minutes had been given to the Board for prior review. A motion was made by Lookabill second by Reisig to approve the minutes as presented. A roll call vote was taken with Howell, Jenkins, Reisig, Fenning, Hoff, and Lookabill voting yes. Motion Carried.

Payroll and bills in the amount of \$221,249.52 were approved on a motion by Jenkins, second by Reisig. A roll call vote was taken with Jenkins, Reisig, Fenning, Hoff, Lookabill and Howell voting yes. Motion Carried.

The financial statement was approved on a motion by Lookabill second by Fenning. A roll call vote was taken with Reisig, Fenning, Hoff, Lookabill, Howell, and Jenkins voting yes. Motion Carried.

The Manager provided a report on the ownership of water in the following reservoirs as of May 31, 2021. Pathfinder Ownership stands at 660,612-acre feet, Guernsey is at 45,612-acre feet and the inland lakes stand at 0.

Water Operations were discussed. It appears that we might be going into an allocated year. It was decided that we would come back in with the water around June 20<sup>th</sup> depending on demand and water conditions.

The claim for damages to center pivot on Lateral # 1 was discussed. The Board feels that we have no liability costs for the damage to the pivot.

An update on the issue with the Bureau of Reclamation on the Guernsey bypass during 2021-2022 was discussed. The Bureau will start the repairs as soon as the irrigation season ends.

We have received a letter from the Natural Resources Conservation Service (NRCS). They have identified the following list of High Hazard Potential Dams within the NPNR District boundaries as Wildhorse 5-A, 9-A and 14-A. They are

encouraging us to review the “FY2022 Dam Assessment Request” and consider applying for the NRCS Rehabilitation funding for dam assessments on these dams. The Board's decision at this time was not to apply for the funding.

LR117 Aging Infrastructure Study Resolution was discussed.

The Watershed Tour for the Board of Directors has been finalized. The Board will be leaving Mitchell, NE on June 10<sup>th</sup> at 7:30 a.m. and returning on the 11<sup>th</sup> of June.

No one appeared during the time set aside for public comment.

The Manager's Report was given as follows:

➤ **Pipeline Project Progress.**

We are waiting on the electrical hookup from Chimney Rock and the pump and motor to be set and hooked up. Once that's completed the project will be complete.

➤ **2020 Legislative Session – LR340 Interim Study.**

The Nebraska State Irrigation Association and the Nebraska Water Resources Association are working together to push for another interim study for 2021. Due to COVID-19 the study sanctioned last year never was accomplished. We have submitted information concerning our District and the potential major costs we could be faced with in the future with aging infrastructure replacement needs. **A draft Study Resolution has been prepared by the State Association for introduction by Senator Bostelman (Nat. Resources Com. Chair). The Association was not making much progress in getting Senator Bostelman to introduce the study, so I reached out to Senator Stinner and he was able to get things moving.**

➤ **NSIA Sponsored NET Video of Water in Nebraska.**

The Nebraska State Irrigation Association this past year sponsored a video working with NET to highlight the importance of water in Nebraska. The name of the video is “Nebraska, the Great American Water Factory”. The video will broadcast on NET sometime in 2021. ➤ **New JD410L Backhoe – Morrill Division**

After a considerable delay from the factory the new John Deere 410L Backhoe for the Morrill Division was delivered on May 25<sup>th</sup>. The purchase price was \$126,320; with a \$25,000 trade and \$19,000 down the District financed the balance of \$82,320 for two years at 2.75%. Payments of \$52,910.61 will be due on June 20<sup>th</sup> of 2022 and 2023.

LB406	McConnell/Natural Resources	01-28-2021  <u>Passed the legislature and was advanced for the Governor signature.</u>	Would create the Lower Platte River Infrastructure Task Force. The Task Force would look at 3-5 potential new infrastructure sites/projects that would help address flood control and water supply in the Lower Platte Region. Main issue is the request to take \$900,000 dollars from the Water Sustainability Fund for a 50/50 match with local funds to conduct the study. This would circumvent the established process for scoring and awarding funding for projects established by the Legislature. <b>The bill gathered significant support from eastern senators and has advanced to final reading with some major amendments. The main objection to this bill was the redirecting of \$900,000 from the Water Sustainability Fund for the study. That has been remedied by the legislature appropriating \$2,000,000 for the study.</b>
LB501	Flood/Judiciary	02-04-2021  <u>Passed the legislature and signed by the Governor.</u>	Would allow for a civil action to be brought by the landowner (servient estate), to force the relocation of an easement. Steve Smith and I developed testimony in opposition for the Nebraska State Irrigation Association (NSIA). Our testimony included a potential amendment to address our concerns, whereby public power & irrigation district, irrigation districts, reclamation districts and canal company right of

			ways would be excluded. NSIA reach out to Senator Flood with our concerns and he has agreed to introduce our amendment at the hearing. <b>The bill has been selected by the Speaker as a priority bill and will reach the floor for debate. Senator Flood has introduced AM 671 to exclude easements held by irrigation districts, canal companies and public power and irrigation districts. The bill has passed the legislature.</b>
LB507	Bostelman	02-03-2021 <b><u>LB507 passed the legislature and was signed by the Govrenor.</u></b>	The original bill was to restrict the use of treated seed corn in the production of ethanol if it results in the byproduct being unsafe for livestock consumption. <b>This is the Christmas Tree Bill that LB190 and LB191 are amended into. It also contains provisions from another LB395 bill dealing with special landowner permits to address wildlife damages to ag lands. The bill has passed the legislature.</b>
